To All Parties:

**RE: Schwarzenegger Judicial Cover-Up - Passing Senate Bill (SBX- 211), Honest Service Fraud (18 USC 1346) & Violations and Deprivations of Rights Under the Constitution and All Rights**

Attorney Richard Fine was incarcerated a few months ago in the Los Angeles Superior Court after uncovering a court and county scheme. Mr. Fine was disbarred from The State Bar, which appears to be a major organized crime racketeering foreign operation. The Bar's in this country at times seek removal of honest attorneys when they prove corruption in the courts or improprieties in cases, especially where schemes exist. Judge Yaffe who held Mr. Fine in Contempt is a judge involved in this corruption scheme, which Mr. Fine brought to light. Mr. Fine's rights are continually being violated and he must be released from prison immediately.

Attorney General Holder, Mr. Fine wrote you about this situation on 2/23/09. I personally alerted Deputy AG Nathan Barankin and others in California to this event on 3/19/09. Why is Mr. Fine still being violated in jail and not allowed to file a Writ of Habeas Corpus? Mr. Fine is in jail because court corruption is out of control and the judge appears crooked.

In the October 2008 ruling of case (Sturgeon vs. County of Los Angeles) it held the illegal payments by judges were unlawful and violate the Constitution. The California Constitution (Sec. 17, 19, 20) states that judges may not receive money from other parties than their employer, the State of California, and the Legislature has the sole responsibility for setting compensation and retirement benefits. Judges are taking bribes and payoffs, besides other illegal payments in California Courts and other states throughout this country, I know this upfront and personal. The judges have been doing this for some time illegally.

Governor Arnold Schwarzenegger signed on 2/20/09, Senate Bill (SBX 211) which grants under SEC. 5 Notwithstanding any other law, no governmental entity, or officer or employee of a governmental entity, shall incur any liability or be subject to prosecution or disciplinary because of benefits provided to a judge under the official action of a governmental entity prior to the effective date of this act on the ground that those benefits were not authorized under law. COVER-UP - IMMUNITY FOR CRIME!

Well the sheer signing of Senate Bill (SBX 211) shows conspiracy, treason, aiding and abetting, honest service fraud and other criminal acts by Governor Arnold Schwarzenegger after a Constitutional Ruling was made and the law already existed and was violated for years. Any party whom created Senate Bill (SBX 211) should be investigated for conspiracy, treason, and indicted. Concealing crime only fosters crime and there is tons of crime in these courts by attorneys, judges, and agencies.

The jig has been up for years on judicial corruption and the foreign entities violating the Constitution and all rights to the American people in these courts. A great hypocrisy exists. Governor Arnold Schwarzenegger is

directly involved in my Civil Case #461990 at the San Mateo Superior Court where he was subpoenaed in May 2008 for a trial on this corruption. I received a fraud ruling by Judge Weiner in 4/08, though the court tried to steal my punitive damages. I spoke directly with Deputy AG Nathan Barankin on the day my Constitutional Right was violated for trial in a case against Attorney Eileen Avila, I was defrauded in a divorce. The corruption in my crime was unbelievable. I became outspoken on the harm I kept sustaining as well as for others being harmed in society. Community Property Laws are violated another Honest Service Fraud. The San Mateo Superior Court and I were defrauded in an attorney and judge scheme with Commissioner Richard Dubois. Richard Smith of First Mercury Fin'l (FMR) the insurer for Attorney Eileen Avila and four attorneys of Wilson, Elser, Moskowitz, Edelman, & Dicker made a payoff to a Judge John Schwartz and are committing insurance fraud. The court looks like morons in how the court and myself were defrauded, nevertheless the continued harm, violation and deprivation of my rights and life. Why is my case still unresolved? In a sense its good now to expose the Governor's personal knowledge on court corruption and the cover-up with (SBX 211).

The lacking procedures and cover-ups immense by agencies. I've been asking for prosecution and firings of Rachel Grunberg and decision makers in my matter at the State Bar and Frederick Ohlrich, the Clerk of the Supreme Court in San Francisco. These parties and others are allowing tremendous harm to California residents. NO PROCEDURES OR AUTHORITY EXISTS! These problems escalate to the Jury Commissioners, County Attorneys, Judicial Oversight and Grievance Committees, the DA's office, County Clerks Offices, The Administrator of the Courts, Sheriffs in areas, The F.B.I ... NO ONE OPERATES! The public is unprotected from this corruption, these conditions are inhumane and sadistic to steal and oppress. A public health crisis exists from the traumas, victimizations, and torturous conditions implemented to harm Americans.

The California DOJ is crippled by corruption of these non-operational judicial offices in the state, as they do not operate themselves. If these people cannot do there jobs, they need to be fired and indicted if necessary. Still to this day Deputy AG Barankin has chosen to keep harming me, allowing my crime to continue in New York with identity theft, fraud, and many types of crime. I expect prosecution and settlements in New York too! I thoroughly learned AG Cuomo's offices are completely inoperable as a Judge Gerald Connolly has repeatedly tried to pass off identity theft, impersonations, and fraud of my person besides other numerous crimes with crooked attorneys, County Attorneys, and how can I forget Safeguard Properties. Safeguard has been breaking and entering, caused property damage, and committed criminal trespass in my property for a year and a half. The shipping of cases out of the Ulster County Supreme Court to Albany a direct violation of court procedures and documentation. I command my property, very huge settlements now, even from the U.S. Government for the deprivation of my rights, property loss, my physical injuries, two destroyed businesses, and continued harm to my life by inoperable agencies, while I fight crooks in courts. I seek indictments and will file criminal charges myself on all parties I mention from my case directly in court, I request a U.S. Attorney be assigned.

I have never been so repulsed to have numerous people watching me be continually harmed knowing I am a crime victim. The same repulsion has me outraged at what is happening to Mr. Richard Fine and the many Americans being needlessly harmed. No one who commits criminal acts should be granted immunity, NO ONE! I expect numerous job firings and indictments, not just in my matter but throughout this country. A task force should be established as complaints are with many parties. It's very easy to pinpoint main crooked attorneys and judges, nevertheless parties in agencies. All political representatives know the harms taking place to Americans as they get many complaints yearly. A system must be devised to track this corruption so it is halted and never violates Americans Rights again, this deceit and torture must end.

I've written Governor Schwarzenegger numerous times taking issues up on this corruption. The Governor's direct violation of my Constitutional Right to due process in a crime, plus with a payoff to a judge in a fraud scheme in that same case shows the Governor's knowledge to this corruption. The Governor's passing of (SBX 211) shows him to be irresponsible and a conspirator in crime. I expect the Governor to rescind (SBX 211), immediately. I seek criminal charges be brought against the Governor and hope Judicial Watch assists in filing these charges, as stated I want a U.S. Attorney assigned. The Governor should be Impeached knowing what he knows on this corruption and his passing of (SBX 211). This is conspiracy and a treasonous act to cover-up and aid and abet the corruption in California courts. How many Californians and Americans have been harmed, too

many!!! Why is an innocent man sitting in jail while a crooked judge sits on the bench?

The Fed set-up this foreclosure debacle to harm Americans and take down the banks and businesses. The foreclosures are full of fraud to rob and steal. A major point Judicial Watch, is the selling of all the mortgages makes the banks just a service provider. NO CONTRACTS exist between the people and the lender currently holding the loan. The banks trying to now hold peoples social security checks etc. should be halted, the same with all foreclosures. The double, triple, octo-dipping of the same funds is all thats taking place. Bogus worthless money to boot from monetization. How much money was given out? How much money was written off? How much money stolen or laundered? Many of these companies should never have been bailed out.

Mr. Fine, myself, and many others, we command our freedom from these abusers, victimizers, and torturers.

Governor Schwarzenegger all I have to say to you is your a disgusting disgrace, go back to Austria where you belong. Governor your a traitor to all Californians and the American people as well as a variety of other parties whom receive this letter. Attorney General Holder I most certainly hope your not a COWARD ON JUSTICE!
